Valley Stream Central School District Enrollment Agreement

You have enrolled in this program for the purpose of preparing for the SAT, ACT or PSAT. All program techniques and materials (online and print) are the exclusive property of The Princeton Review, Inc. ("TPR"/"we"/"us"/"our"). You agree not to disclose, reproduce, sell or distribute to any third party any information, written or spoken, including course materials, obtained from TPR in connection with TPR courses or tutoring programs. You understand that course size is limited and, therefore, enrollment is taken on a first-come, first-served basis.

Course Cancellation - Please note that TPR may sometimes change course schedules and locations and, occasionally, cancel a course. If you decide to cancel your enrollment within ten days of the first session of your program, we will refund all of the tuition you have paid less your deposit. No refunds will be given after the first session of the program in which you enrolled. You must return to us all program materials that you have received within two weeks of canceling your enrollment. No refunds will be processed until we have received all of your program materials. Please note that refunds take approximately six weeks to be processed. Private tutoring programs are non-refundable.
